Aim of the workshop:

This international workshop is based on results from the assessment of sediment management-related **good practices and potential measures**. The project collected these practical measures throughout the Danube River Basin. We will present recommendations that aim to improve the sediment management in the Danube River in order to mitigate the impact of significant pressures on the ecological status of the river.

The workshop will begin by presenting some good practices including technical, ecological and organisational measures. Discussions will help to receive an input for the final reports about measures. This will include an analysis of the technical feasibility and an estimation of the impact a measure has on key stakeholders, such as hydropower, flood protection, navigation and nature protection.

The main goal of the workshop is to discuss the project recommendations and ideas for getting inputs about sediment-related good practice measures together with stakeholders from different sectors of sediment management.
